**WHAT:** The Annie & Mary Day committee invites you to join our annual celebration by having a booth in our arts & crafts area. All crafts such as ceramics, leatherworks, painting, sewn & knit items, woodwork and jewelry, as well as the new and different are welcome and encouraged!

**WHEN:** Annie & Mary Day will be on Sunday, July 14<sup>th</sup> this year. Set-up will begin at 8:30am. Booths should be ready by 11:00am. Your booth area will be indicated by a wood stake with your name on it. Deadline for receiving booth registrations will be Monday, July 8<sup>th</sup>, 2024.

**WHERE:** Arts and crafts section will be located at the baseball field that is connected to Perigot Park. This will allow for direct flow of event attendees from the main lawn in front of the stage and the food areas. This will also allow arts & crafts vendors to more easily participate in the festivities and listen to the music.

**BOOTH SPACE:** Each applicant will be provided with a space measuring approximately 10' x 10'. An applicant must provide his or her own tables, chairs, counters or whatever is necessary to display the wares. All vendors must carry their own liability insurance, have a Blue Lake Business License and proper permits in place. A Business License Application has been attached for your convenience and can be returned to Blue Lake City Hall.

**HOW MUCH:** Each booth (10' x 10') will cost a fee of \$50, payable upon registration. Registration deadline for booth space is Monday, July 8<sup>th</sup>. Cash and checks accepted.
